The outer side is resistant to abrasion, and is both waterproof and windproof. The inner side provides excellent breathability and quickly wicks sweat away to the surface. Four-way stretching enables total freedom of motion. The jacket has a light hood lined with elastic, a protective chin cover, a zippered chest pocket, two zippered pockets, anatomically shaped sleeves with elastic cuffs, an extended back, and internal stopper cords to adjust the fit. Reflective print for greater safety. A fitted slim cut, functional elastic Tabiflex® material that adjusts to every motion, and a soft finish on the inside guarantees comfort in all situations. The men's jacket suitable for demanding work, sports, and outdoor activities.
