DESCRIPTION

The Men's ARDON®NYPAXX® jacket made from a combination of a quilted 3-layer front and back and lightweight sleeves. The insulated parts are made of a pleasant lightweight material with padding that retains heat and protects against wind. Two zipper side pockets, a visible front zipper with chin protection, reflective elements for better visibility, and a quilted hood complete the overall design.
