**DESCRIPTION**

A softshell jacket with a hood made of elastic ElasticTech®Flexi material; the inner part is lined with pleasant fl eece. This jacket with raglan sleeves has an anatomically shaped functional SLIM FIT cut. It features a detachable hood which can be adjusted with a drawstring. The jacket has a continuous zipper with a chin guard, is equipped with 1 zipper chest pocket and 1 zipper pocket on the left sleeve, and 2 covered zipper side pockets. The jacket has pre-shaped sleeves. The width of the bottom hem is adjustable with stoppers, for safe movement, it is equipped with high-visibility elements. The jacket protects the wearing against rain thanks to its functional membrane while maintaining optimal breathability and wind resistance. The modern design makes the jacket suitable for versatile use during outdoor, work and leisure activities.
