The women's softshell jacket in a sophisticated cut with raglan sleeves protects you from the wind and keeps you dry thanks to the functional ElasticTech®-Flexi material with membrane. The jacket is waterproof, windproof and breathable at the same time. The circumference of the detachable hood and the bottom edge of the jacket can be adjusted with stoppers. The inner part consists of a pleasant fleece fabric. The jacket has an anatomically shaped functional SLIM FIT, continuous zipper with chin guard, 1 zippered chest pocket and 1 zippered pocket on the left sleeve, 2 zippered side pockets. For safety precautions, it is equipped with reflective elements. Thanks to the modern design, the jacket has versatile use in outdoor, sports and leisure activities.
