## DESCRIPTION

A women's polo shirt made of pre-washed cotton, which is more resistant to colour bleeding, and especially eliminates shrinkage after washing. The polo shirt made of pique cotton features a collar with a design element also found on the sleeve hem. The button placket is reinforced with a decorative patch, the bottom piece is extended and has side slits. The modern cut of the sleeves emphasizes the shape of the shoulders. The fabric is treated with a silicone layer that softens the surface, adds shine and extends the life of the product. The polo shirt has only a small size label sewn into the neckline and a label with material and maintenance information. The monochrome ZERO LABEL design makes the polo shirt the ideal product for merchandise and creative designs.
