DESCRIPTION

Stretch cotton shorts made of special material Amylytton[®], which ensures increased strength and durability of cotton fabric while maintaining comfort, elasticity and all the benefits of natural material such as breathability and pleasant feeling when wearing. Extra durable super elastic Tabiflex[®] material is used on the most stressed areas. The shorts have a highly ergonomic and functional fit. Elastic waist along with concealed back double loop for a strengthened placement of the belt. The shorts are equipped with a D ring, 2 deep tactile pockets, 1 front zipper pocket, 1 front tool pocket with a wide loop. On the right leg there is a multifunctional pocket for a folding ruler, a screwdriver and a cutter-off knife with wide loops, on the left leg there is a large double pocket covered with a snap fastener. The back part is divided by a saddle and 2 pockets, the right rear pocket is covered by a snap fastener. The bottom hem of the leg is reinforced with Oxford anti-abrasion material. Increased visibility of the user is ensured by reflective strips located on the front and back together with hi-vis accessories.
